Steps to Make a Charitable Gift of Grain

In order to receive the intended tax benefits, you should follow these steps to ensure that owner-ship of the gifted grain is transferred prior to sale.

- 1. Contact the RMH Foundation (RMHF) at 765-932-7568 to let us know a gift of grain is about to be made.
- 2. The RMH Foundation will set up an account at the elevator.
- 3. Deliver the grain to the elevator.
- 4. Transfer the grain as a gift to the RMHF by having the elevator send a warehouse storage receipt to us.

The elevator's receipt must show RMHF as the owner of the grain. (Avoid making a gift of an actual warehouse receipt, give grain itself.)

- 5. Fill out and mail the Gift of Grain Donation Form to us. We will provide you with a letter acknowledging your gift to keep for your tax records.
- 6. After the gift is made, RMHF will sell the grain the day we are notified, and put the sales proceeds into your fund of choice. Any sales invoice will name the Rush Memorial Hospital Foundation as the seller of the grain.

In a nutshell . . .

Take your crop to your grain buyer, tell the company how much of the grain you want to put into an account for the RMH Foundation. The grain buyer notifies RMHF, which will then sell the bushels the day we are notified.

Why Donate Grain Directly?

For many cash-basis farmers, significant tax savings can be achieved by donating crops directly to the Rush Memorial Hospital Foundation.

Tax Savings Cash charitable contributions are deductible only as an itemized deduction from adjusted gross income which results in reducing federal income tax only. Many farmers do not itemize deductions because the standard deduction has greatly increased over the years.

By contributing crops to the Rush Memorial Hospital Foundation, the cash basis farmer avoids having to include the sale of the cash crop income, which results in saving self-employment tax, federal income tax, and state income tax.



Use Professional Advisors

The farmer should always consult with his or her professional tax or legal advisors to determine tax implications prior to making the gift. Because of rapid changes in tax law, information provided here may be obsolete.

Crop Share Landlords Åre Not Eligible

Shares of crop are a rental income that must be included in the reportable income by the landlord.
